

OFFICIAL RULES OF THE "THE DAY OF YOUR LIFE" GIVEAWAY

1. Organizing company

The company **Mallorca Sailing Catamaráns S.L.**, with registered office at **Carles Ribas, 10, 07004 [●]** (city/province to be confirmed in the final text), Tax ID (NIF/CIF) **B07919566**, hereinafter, **"the Organizer"**, organizes the promotion named **"THE DAY OF YOUR LIFE"** (hereinafter, the "Giveaway"), which will take place through the official Instagram profile **@attractioncatamarans**.

Participation in the Giveaway is free of charge and is not conditional on the purchase or contracting of any product or service.

2. Purpose of the promotion

The purpose of the Giveaway is to promote the **Attraction** brand and its catamaran tour and experience services in Mallorca.

Participation in the Giveaway implies full acceptance of these Official Rules.

3. Duration

The participation period will begin on **August 31, 2026** at **5:00 PM (CEST)** and will end on **September 10, 2026** at **4:00 PM (CEST)**.

Entries submitted outside this period will not be accepted.

The winner will be selected and announced on **September 10, 2026**, between **5:00 PM** and **7:00 PM**, once the participation period has ended.

4. Eligibility requirements

Individuals who meet all of the following requirements may participate in the Giveaway:

1. Be at least **18 years old** at the time of participation.
2. Hold a valid, public Instagram account throughout the participation period and until eligibility is verified.
3. Follow the official Instagram account **@attractioncatamarans**.
4. "Like" the official Giveaway post.
5. Leave a comment on the Giveaway post mentioning the person(s) they would share the prize with.
6. Meet the remaining conditions set out in these Rules.

An entry will only be valid once all mandatory requirements have been met.

The Organizer may verify that the selected winner meets the requirements before final confirmation of the prize.

Employees of the Organizer, individuals directly and professionally involved in organizing the Giveaway, and their immediate family members may not participate.

The Organizer reserves the right to exclude any entries it considers fraudulent, duplicated, automated, made through fake accounts, or in breach of these Rules.

5. Giveaway mechanics

To participate, entrants must:

- * Follow **@attractioncatamarans** on Instagram.
- * "Like" the official Giveaway post.
- * Comment on that post **tagging with @** at least one person they would enjoy the prize with.

Each person may enter as many times as they wish through different comments, provided each comment meets the stated conditions.

The Organizer may limit or invalidate entries it considers clearly automated, repetitive, fraudulent, or made solely to manipulate the outcome of the Giveaway.

Participation does not imply any obligation to purchase.

6. Prize

The prize consists of a **private catamaran sailing experience lasting four (4) hours** for the winner and the people they choose to invite.

The winner may enjoy the experience together with **up to 55 guests**, meaning the maximum total number of passengers will be **56 people, including the winner**.

The winner may freely choose their guests, provided the maximum authorized capacity of the vessel is respected at all times.

The prize includes:

- * Private catamaran sailing experience for four (4) hours.
- * Exclusive use of the vessel during the experience.
- * Crew required for sailing and operating the vessel.
- * Private sailing experience in Mallorca.

The prize **does not include**:

- * Food.
- * Catering.
- * Drinks.
- * Catering/hospitality services.
- * Decoration.
- * DJ services.
- * Entertainment services.
- * Transport to or from the departure point.
- * Any other service not expressly listed as included in these Rules.

Bringing on board food, drinks, or catering products purchased, prepared, or brought from outside the vessel is not permitted.

The experience does not constitute a "party boat." The winner and their guests must comply at all times with the safety, navigation, and conduct rules established by the Organizer and the crew.

Activities or behavior that could endanger passengers, crew, or the vessel, or that are incompatible with applicable maritime regulations, are not permitted.

The prize refers exclusively to the private sailing experience described in these Rules and **does not constitute ownership, transfer, lease, or delivery of the vessel to the winner**.

If the winner chooses to enjoy the experience with fewer than 55 guests, the unused places will simply be considered unused and **will not give rise to any right to**

financial compensation, substitution, extension of the prize, or an alternative benefit**.

7. Terms of use and booking of the prize

The experience will last **four (4) hours**.

The prize should preferably be enjoyed during **October 2026**.

The specific date must be agreed in advance with the **Organizer's office team**, and will always be subject to vessel availability and the Organizer's operational schedule.

The winner may not unilaterally set the date of the experience; it must be agreed in advance with the office team.

If the winner is unable to enjoy the prize during October 2026, they may request to enjoy the experience during **2027**, subject to coordination and confirmation with the office team.

To enjoy the prize during 2027, the winner must request and agree the date with the Organizer with a **minimum notice of two (2) months** before the requested date.

The final agreed date will always be subject to vessel availability and the Organizer's operational conditions.

The prize must be enjoyed in a single four (4) hour experience and may not be split into several outings.

If the activity cannot take place on the agreed date due to weather conditions, adverse sea conditions, navigation restrictions, breakdowns, force majeure, or other circumstances that could compromise the safety of passengers or crew, the Organizer may change the date of the experience, seeking to agree a new available date with the winner.

The final decision regarding the safety and feasibility of the outing will rest with the Organizer and/or the vessel's captain.

8. Selection of the winner

Once the participation period has ended, a random draw will be held among the entries that meet the requirements set out in these Rules.

The following will be selected:

* **One (1) main winner.**

* **Three (3) alternates**, who will be used in the event that the main winner does not meet the requirements, waives the prize, or does not respond within the established deadline.

Selection will be carried out using **a web-based giveaway/raffle application**, ensuring a random process.

The Organizer will keep evidence of the winner selection process.

9. Notification of the winner

The winner will be announced on **September 10, 2026, between 5:00 PM and 7:00 PM**, through the Stories and/or a post on the official Attraction profile

(@attractioncatamarans).

The Organizer will also contact the winner via private message on Instagram.

The winner will have ****7 days**** from the first contact attempt to respond and confirm they meet the requirements.

If the winner does not respond within this period, does not meet the requirements, or waives the prize, the first alternate will be contacted and ****publicly announced as the new winner of the Giveaway****.

If it is also not possible to award the prize to the first alternate, the same process will be followed with the subsequent alternates.

If none of the alternates can receive the prize, the Giveaway may be declared void.

10. Verification of the winner

Before confirming the award of the prize, the Organizer may request from the winner the information necessary to verify their identity, age, and compliance with these Rules.

The Organizer may request:

- * Full name.
- * Date of birth.
- * Proof of identity document.
- * Contact details.
- * Information necessary to manage the booking and delivery of the prize.

The data will be processed in accordance with applicable data protection regulations and as set out in the Organizer's privacy policy.

11. Personal and non-transferable prize

The prize will be awarded exclusively to the person who is the winner.

The winner may invite whomever they wish to enjoy the experience, up to a maximum of ****55 guests****, in addition to the winner.

The maximum will therefore be ****56 passengers in total****.

The winner may not exchange the experience for money, sell it, auction it, or commercialize it to third parties.

Use of the prize with fewer guests than the maximum permitted will not give rise to any right to financial compensation or any other additional benefit.

The prize may not be exchanged for money or other services, unless the Organizer, on an exceptional basis, agrees otherwise in writing.

12. Taxation

The prize will be subject to applicable tax regulations in Spain.

If it is mandatory to apply withholding tax or a payment on account regarding the prize, the Organizer will comply with the tax obligations legally applicable to it.

The winner will be informed, where applicable, of the taxable value of the prize

and the amounts subject to withholding or payment on account.

The Organizer may request from the winner the information necessary to comply with its tax obligations and issue, where appropriate, the corresponding certificate.

13. Modification or cancellation of the Giveaway

The Organizer reserves the right to modify, suspend, or cancel the Giveaway in the event of force majeure, exceptional circumstances, or any other circumstance that prevents it from being properly carried out.

In the event of modification, suspension, or cancellation, the Organizer will inform participants through its official channels whenever possible.

The Organizer will not be liable for circumstances beyond its control that prevent participation, communication with the winner, or delivery of the prize.

14. Liability

The Organizer will not be liable for:

- * Failures, interruptions, or technical issues with Instagram.
- * Loss of connection or platform malfunctions.
- * Entries that could not be recorded due to technical causes beyond the Organizer's control.
- * Fake profiles or identity theft carried out by third parties.
- * Damage arising from failure by the winner or their guests to comply with safety and navigation rules.

The winner and their guests must follow the crew's and captain's instructions at all times.

The Organizer may prevent any person who breaches safety or conduct rules from taking part in the activity, without this giving rise to any right to compensation.

15. Personal data protection

Personal data provided by the winner will be processed by ****Mallorca Sailing Catamaráns S.L.****, for the purpose of managing the award and delivery of the prize, verifying compliance with these Rules, and complying with applicable legal obligations.

The legal basis for the processing will be the performance of the relationship arising from participation in the Giveaway and compliance with applicable legal obligations.

Data will be retained for as long as necessary to manage the Giveaway and comply with the relevant legal obligations.

Data subjects may exercise their rights of access, rectification, erasure, objection, restriction, and portability, where applicable, by contacting ****mallorcatamaran@gmail.com****.

Participation in the Giveaway does not automatically enroll the participant in any commercial communications database, nor does it authorize sending marketing

communications, unless the participant expressly gives such consent through a valid means.

16. Publication of the winner's name

The winner agrees that the Organizer may publicly share their Instagram username for the purpose of announcing the result of the Giveaway.

Any additional use of images, photographs, videos, or testimonials from the winner will require the corresponding authorization, where necessary.

17. Instagram

The Giveaway is not sponsored, endorsed, administered by, or associated in any way with Instagram.

Each participant releases Instagram from any liability related to the running of the Giveaway.

Participants acknowledge that they are providing their information to the Organizer and not to Instagram.

Instagram will not be responsible for managing the Giveaway or delivering the prize.

18. Acceptance of the Rules

Participation in the Giveaway implies full acceptance of these Official Rules.

Failure to comply with any of the established requirements may result in exclusion from participation and, where applicable, forfeiture of the right to the prize.

These Rules will be available throughout the participation period on the Attraction website, published from the start of the Giveaway (**attractioncatamarans.com**).

19. Applicable law and jurisdiction

These Rules shall be governed by applicable Spanish law.

For any dispute arising from the interpretation or application of these Rules, the courts and tribunals with jurisdiction under applicable law shall have competence.
